Public Forum-

A Parishioner bought up the subject of the post box. We discussed its

was not imminent, if at all as we have not had any official notification from
the Post Office.

- County Councillor Aquarone was absent to present his report.

Matters arising from the meeting held on Monday 21st November 2022.

Overgrown Vegetation- Church Lane this has been resolved but the clearance of the
debris was not to an acceptable standard and this was reported to Astley Estate
offices. The hedgerow that is sited at the property of Parish Councillor Gary May and
the hedgerow adjoining the public footpath along St. Giles Road through to Church
Lane was also severely cut back resulting in extensive removal of vegetation and the
waste was left discarded on the ground by the contractors that had completed the
work.

- Parish Councillor Gary May invited Lord Hastings and Farm Manger Luke Rodway to attend the property to view the work that had been completed. Lord Hastings agreed the work had been extensive and overzealous, the condition of the area where the debris had been left was commented upon and was agreed that this was unacceptable to be left this way by the contractors hired to complete the work.

- Potholes- The pothole that was repaired recently opposite to West Harrow/ Fieldfare houses along The Street has again appeared and will need further repair and is required before the winter period, email sent to Norfolk Highways for further repair.
- A further pothole has appeared in St. Giles Road at the entrance to The Old Vicarage which is also to be reported to Norfolk Highways for repair.

Affordable Housing update- Ian Watson Secretary Swanton Novers Community Land Trust

- The Swanton Novers Community Land Trust secretary Ian Watson mentioned that all statutory consultation responses to the planning application have now been received.
- The responses to the planning application have been very positive. The NNDC have however suggested that greater variation to the western elevation of Plots 1-3 (the block of three houses) is required to enhance long views into the site from the west and to better assimilate with the rural setting.
- Also, the plan to retain a consistent ridgeline here to reflect the barn/farmyard design, some variation to the windows to the rear of the properties to overcome the council's concerns will mean the minor adjustments will need to be submitted and to update the planning application.
- It is anticipated that approval of the development will be forth coming but may not be until the spring.
