- District Councillor Martin Hankins attended the meeting. A brief introduction of the
 newly elected councillor was received to the Parish Council. Expectations were
 discussed in what was expected by a local council District Councillor. It was also
 commented on how Parish Councils may be able to support each other and share
 information that might give benefit to each Parish. District Councillor Hankins
 commented that he would be attending a meeting at North Norfolk District Council
 to obtain information regarding his role and how to support the local Parish

 the District Councillor once the meeting had been held.

• Road Markings/ Give Way Sign. – Norfolk Highways emailed to highlight the issues of the potholes In St. Giles Road and The Street opposite Rest Harrow residence and why the road repair has not been completed.

- Potholes- The pothole that was repaired opposite to West Harrow/ Fieldfare houses along The Street in 2022 has again appeared and will need further repair, email sent to Norfolk Highways to why the repair has not been actioned.

Affordable Housing update- Ian Watson Secretary Swanton Novers Community Land Trust

- The Swanton Novers Community Land Trust secretary Ian Watson mentioned that all statutory consultation responses to the planning application have now been received.
- Broadland Housing (the developer) is liaising with Rivers Ecology to seek a solution to nutrient neutrality at the site. Since March 2022 all new housing developments are required to demonstrate as part of the planning application that they can accommodate the nutrient load generated by the proposed development.
- A site visit was completed by CLT to inspect the air source heat pumps at a new
 development site at Docking, Norfolk to view the insulation and noise created by
 these systems as a guide to see the impact these would have on the village if these
 were to be installed at the new development within the village. All those who
 attended were impressed with the installations and the quietness of the running of
 the units and the siting of them within the properties.
